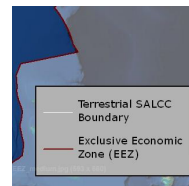
Instream Flows Project Approved!

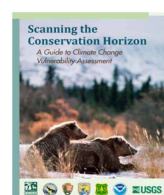
